3. Decision to reschedule or cancel due to inclement weather or other reason is at the discretion of Arnold Golf Club Management.
4. Player count is required seven (7) days prior to event with roster. Sole access to course for the duration of the event is dependent on a minimum of 100 players. Less than 100 players may result in the course being open to the public before during the event in a manner that will not disrupt event play.
5. If AGC is providing scoring for the event, the player roster should be typed including first and last name of each player with players grouped into the appropriate teams. Final rosters submitted less than two days prior to event may result in incorrect cart signs, scorecards, etc.
6. Food and beverage numbers are required seven (7) days prior to event. Be sure to include event staff who are not playing in the event.
7. Players and/or Food/Beverage numbers may be increased up to the day of event, but cannot be reduced later than seven (7) days prior.
8. Event representative is responsible for final payment **on the day of event** unless prior arrangement is made with Arnold Golf Club management. Payment may be made using cash, company check or major credit card.
9. Any damage to golf course, carts or buildings within the boundaries of Arnold Golf Club may be subject to billing the event at full retail price for repair.
